## General Terms & Conditions

1. By applying for a Europcar charge card the applicant accepts that Europcar AMAG Services AG may forward the information provided on the application form to a credit reference agency for the purpose of obtaining a credit report.
2. The Europcar charge card entitles the holder to rent a car in the country and at all foreign Europcar contract partners on a credit basis. The natural or legal person named on the Europcar charge card (hereinafter termed "holder") confirms to Europcar that by signing and/or using the Europcar charge card he/she accepts the following terms and conditions.
3. Cards will only be accepted and vehicles will only be provided if the user is able to prove his/her identity as a cardholder by way of at least a driving licence.
4. The holder shall pay to Europcar the total amount of rental charges incurred through use of the Europcar charge card immediately after receipt of the invoice, at the latest within 30 days thereof.
5. The holder shall notify Europcar in writing of any change of address. Should the holder fail to do so, Europcar shall be entitled to cancel the charge card. The holder undertakes to only apply for and use the Europcar charge card if he/she is in a suitable financial position.
6. Rental charges from rentals effected at Europcar contractual partners abroad will be charged to the holder in Swiss francs, applying the exchange rate valid on the day the invoice is received at the Europcar administrative centre in Kloten.
7. The holder undertakes to also pay all charges incurred by non-authorised persons using the Europcar charge card, regardless of whether or not such use was authorised by the holder.
8. If a Europcar charge card should be lost or stolen the holder shall, without delay, notify Europcar Sales Departement, Steinackerstrasse 20, 8302 Kloten, in writing by post or fax (044 804 46 47). The holder shall not be liable for charges incurred as a consequence of rentals effected after the time at which Europcar was verifiably notified of the loss or theft of the Europcar charge card.
9. Europcar may issue block lists to its rental stations and foreign contract partners containing the numbers of charge cards that shall no longer be used for rentals. Europcar shall not be liable for damage suffered by the holder as a consequence of numbers of Europcar charge cards that were erroneously included in the block lists.
10. The Europcar charge card remains the property of Europcar. Europcar reserves the right to withdraw, without statement of reasons, the right to use the Europcar charge card. The Europcar charge card shall be returned immediately if so requested by Europcar.
11. The holder accepts Zurich as place of jurisdiction.
12. The Europcar charge cards are issued free of charge.
