

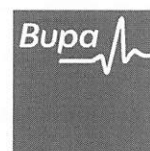

## 6 Your consent to obtain a medical report

### Important information

In order to process your claim, we may need to apply for a medical report from any doctor who has attended you. To apply, we need you to give your consent by signing the declaration below.

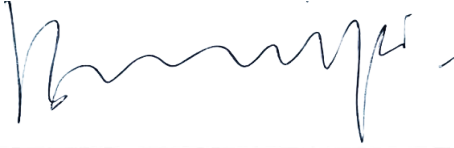

## **Surgery report**

**Indication:** Histologically confirmed vaginal condylomata acuminata  
**Surgery:** CO2 laser therapy vaginal, biopsy vaginal, anoscopy, cytology anal  
**Duration:** 40 minutes  
**Bloodloss:** 5 ml  
**Diagnosis:** Histologically confirmed vaginal condylomata acuminata

- 10/2023 LSIL, HPV 59, 82 (high risk), 42 (low risk); vaginal biopsy at 3 and 9 o'clock, middle third: condylomata acuminata, no evidence of dysplasia
- 03/2023 LSIL, HPV 54 (low risk)
- 11/2022 vaginal hysterectomy with bilateral salpingectomy, colpoperineoplasty, sacrospinous fixation for urogenital descent (histology: CIN I)
- 08/2022 LSIL
- 05/2022 LSIL, HPV 56, 66 (high risk), 54 (low risk)
- 11/2021 histolog. LSIL/CIN I at 12 o'clock, cytologic LSIL

## **Operatin procedure:**

Inspection: External genitalia age-appropriate. Multiple condylomatoid lesions on the vaginal walls are already visible in the native examination. The condyloma predominantly affects the lateral walls on both sides. After application of vinegar the lesions are clearly positive. In the area of the posterior wall, a small elevation is seen in the caudal third at 6-7 o'clock, DD scar tissue after vaginal surgery. The site is biopsied to be on the safe side. Colpotomy area well fixed, visible and unremarkable.

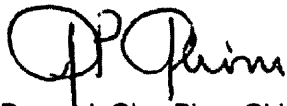
CO2 laser therapy, anoscopy and collection of anal cytology sample: Disinfection of the vagina with chlorhexidine and dabbing with 2% vinegar solution. See above for findings. Under colposcopic view, the condylomas are evaporated in layers to a depth of 1 mm. In between, the tissue is dabbed with a moist

gauze compress. This is followed by anoscopy natively and after application of vinegar: inconspicuous visualization of the anal canal up to the dentate line. Anal cytology sampling. Insertion of a loose oestrogen tamponade and a 14-charrière urinary catheter.

**Procedure:**

- Urinary catheter and tamponade removal on the first postoperative day, thrombosis prophylaxis on the day of surgery.
- Ms. Böschlin will be informed of the cytology and histology results in writing; she will then inform Mrs Redjeki accordingly.
- Postoperative check-up recommended in 6 weeks. After the wounds have healed, off-label treatment with Imiquimod is recommended to reduce the risk of recurrence. An HPV vaccination has already been carried out in advance.
- The next differential colposcopy with Pap sampling and HPV typing should be scheduled in 6 months.
